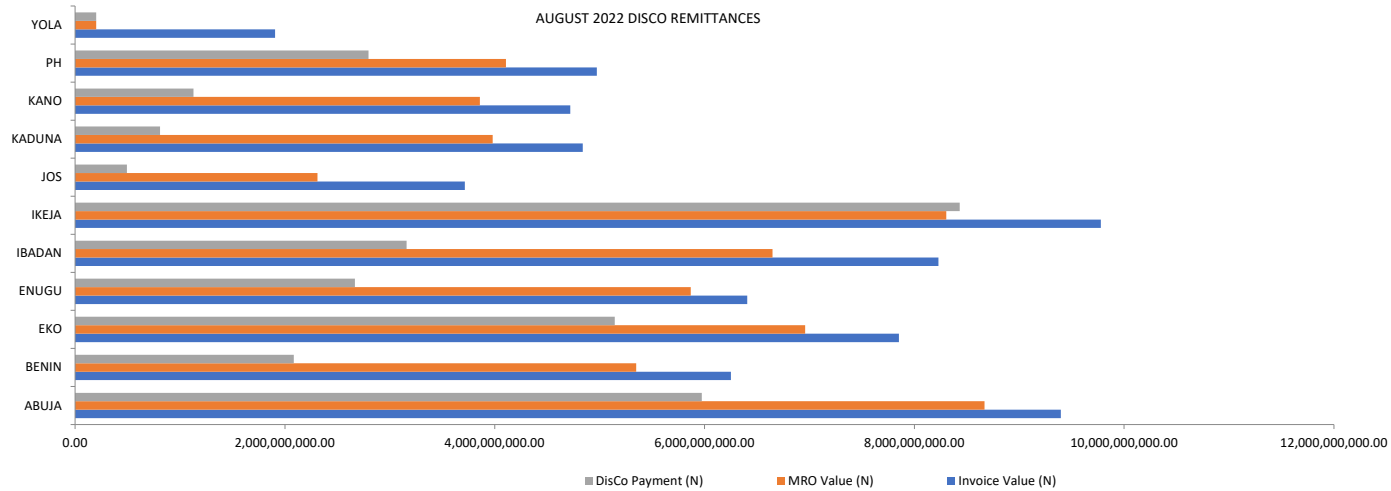

August 2022 DisCo Remittances

1. Discos' expected overall payment performance (based on the Minimum Remittance Order by NERC) is 82.64% but overall DisCo payment performance achieved at the time of generating this report is 74.01% representing 89.55% of the MRO requirements.
2. With the implementation of NERC's order on Regulatory Net-Offs, seven DisCos (Abuja, Benin, Enugu, Ibadan, Kaduna, Kano, Port-Harcourt Discos) have not satisfied the requirements of the Minimum Remittance Order.
3. Subsequent Payments are expected from DisCos with outstanding MRO payments.
4. For DisCos that have surpassed the month's Minimum Remittance obligation, a review of the annual performance will be carried out in respect of the excess payment.
